## COURSE DESCRIPTION

This course immerses students in the world of brand video production. Students explore fundamental branding principles and how they are integrated into visual storytelling. Throughout this course, students will explore creative techniques to develop powerful brand content and expand their creative and production portfolios.

## COURSE OBJECTIVES

The purpose of this class is to introduce students to branded content creation and visual storytelling produced for multiple media types. By the end of the course, students will be able to demonstrate and apply knowledge in the following areas:

- Understand and apply fundamental branding principles effectively in creating impactful branded visual content.
- Develop skills in constructing dynamic, targeted brand content using visual, audio and design elements.
- Utilize visual communication principles and terminology proficiently in branding production.
- Design branded visual content strategically tailored to resonate with the intended audience.
- Execute branded videos that support underlying concepts, values, or messages while aligning with the audience.
- Demonstrate proficiency in using multiple video production equipment types as well as industry-standard design and editing software.
- Understand the roles of brand managers, creatives, producers, and directors throughout the advertising and film production industries, including their responsibilities and collaborative dynamics.

## COURSE COMMUNICATION

Additionally, your input is important! It not only helps guide our discussions, but it also makes our class more interesting. Second, communicating in group settings will help prepare you for future work situations where conversations are used to help solve challenges.
