Course Prerequisites: None.

Course Description: In this course, you will learn the basics of being a public interest communicator by exploring concepts and frameworks that are key to the discipline. We'll delve into the science of message framing, discover how to make people care about big issues, learn how to use communications to mobilize people to act, explore the science of emotions in messaging and much more. For your final project, you'll produce a case study, applying what you have learned to real-world public interest communications campaigns and offering ideas to make the communications efforts more effective.

Course Objectives and Learning Outcomes: By the end of this course, you will be able to:

- 1. Define public interest communications.
- 2. Explain the role of public interest communications in bringing about positive social change.
- 3. Explain key public interest communications concepts and frameworks.
- 4. Identify the strengths and weaknesses of a public interest organization's communications.
- 5. Apply the key concepts and frameworks to current social issues and real-world public interest communications campaigns.
- 6. Explore the many career opportunities in public interest communications.

Tips for success

To be successful in this course, you just need an open mind and a desire to learn, question and explore. You'll do well as long as you come to class, keep up with the assignments and ask questions when you have them.

Note: Grad students taking this course will be given more advanced work in the form of additional assignments or additional components in assignments.

About classroom discussions

I aim to present materials that are respectful of ethnicity, race, culture, gender, sexuality, disability, age and socioeconomic status. However, I recognize the materials may have limitations and encourage suggestions for additional materials that offer different perspectives. Please let me know if you have any ideas as to how to make the course more effective for you and/or other students. If something was said in class (by anyone) that makes you uncomfortable, please talk to me about it. (Anonymous feedback is an option as well). If any class meetings conflict with your religious events, please let me know so that we can make arrangements.

Students are encouraged to employ critical thinking and to rely on data and verifiable sources to interrogate all assigned readings and subject matter in this course as a way of determining whether they agree with their classmates and/or their instructor. No lesson is intended to espouse, promote, advance, inculcate or compel a particular feeling, perception, viewpoint or belief.

Deadlines

Communications work is deadline oriented, so it's important to meet assignment deadlines. If you do miss a deadline and submit your assignment late, I'll still assess it, but I will reduce the total number of points you can receive. The number of possible points will drop over three days to 0. I will make exceptions for students with documented medical emergencies (e.g. a doctor's note) or other genuine, documented emergencies. **Please notify me as soon as possible** if you have an emergency that will prevent you from completing an assignment. This policy doesn't pertain to the final campaign plan and presentation slides; those are due the day of the presentation to the organization. If they aren't complete, the team will get a 0.

Format for writing assignments

Please use Associated Press (AP) style for all writing assignments. If you don't have the AP Stylebook, you can subscribe to it online (https://www.apstylebook.com/ on- line/) or you can purchase a hard copy.

Attribution in writing assignments

I'm sure you have read news stories about careers being derailed because someone copied material from a book, article or other source and represented it as their own (aka plagiarism). That's why, in every assignment for this course, you must clearly attribute the source of your information, including information obtained from organizations' web sites or internal documents. Do not copy anything word for word, regardless of the source, without putting quotes around it and crediting the source. Doing so constitutes plagiarism, which will result in a 0 on the assignment and could lead to disciplinary action.

Artificial intelligence (AI)

In this course, you may be asked to use generative AI for some assignments. Increasingly, AI is used in the profession, so familiarity with generative AI tools is important. However, do not let your creative thinking and editing skills lapse! When AI is allowed or encouraged in assignments, you will need to document how AI was used. This could include providing your original prompts, showing the editing that you did to the created content, or using appropriate citation of information obtained via generative AI.

Using AI when not explicitly allowed is considered a violation of the honor code, as you are presenting content as your own that was not fully created by you.

Various AI detection tools are available (built within Canvas and externally such as ZeroGPT), and many AI platforms follow very formulaic response patterns. If I am concerned that your work is not your own, I will try to verify the originality of your work. If unable to do so, I may ask you to resubmit the assignment detailing how you arrived at your submission.

Course technology

You will need reliable Internet access and a reliable computer with Microsoft Word (or other word processing software that can generate a .doc or .docx file), Adobe flash (for viewing video content) and Adobe PDF reader. **Please bring your computer to class**.

Class attendance

Attendance is important, as class participation is a key part of your learning and will factor into your grade. To get the most out of the class, you must be present and participate in discussions and class activities. Being present doesn't simply mean you're in the room; it also means you're attentive and not texting, checking email, doing other work or using social media during class. Excessive absences will harm your grade.

In the professional world, people who are running late or are going to be absent notify their employer and/or colleagues. It's a good habit to get into, so please notify me and your teammates if you are going to be late or absent. If you do miss class, it is your responsibility to make up lost work, get notes from another student or otherwise ensure that you have caught up on what you missed.

I recognize that things crop up and you may have to miss a class during the semester. For that reason, at the end of the semester, I will drop each student's lowest participation grade.

Class professionalism

Did you know that multitasking during class hinders your ability to absorb information and virtually ensures that you will miss a critical point being made by another student or the instructor? For that reason, please do not text, check email or social media unrelated to the class, browse unrelated websites or do other work during class.

Please be on time to class. Being late means missing updates and announcements, as well as the introduction to the material we are covering, which is key to putting it in context. (See note above about class attendance.)

Grading

Because communications at any public interest organization involves brainstorming and collaborating with colleagues, and because it's more fun to learn by seeking answers to questions through discussion rather than listening to a straight lecture, participating in class will be key to your learning and will be part of your grade. Likewise, the written analyses that you do outside of class will be critical because you will be applying concepts covered in class and in the reading assignments.

Here's how the grading will be weighted:

- > Class participation (includes discussions, activities and in-class writing assignments): 35%
- Writing assignments (done outside of class): 35%
- Final project: case study: 30%

Recording of class

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3)

as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

COURSE SCHEDULE

Note: This schedule may change as the semester advances to reflect the progress and needs of the class.

Week 1 (Jan. 13 and 15) – Welcome!

Welcome! What is public interest communications? What careers can you have as a public interest communicator? What does it mean to be "in the public interest"? We'll discuss these questions, introduce ourselves and talk about the social issues that you care about most.

Week 2 (Jan. 22 only) - Campaign selection

This week we'll go over the criteria for selecting a campaign to follow over the semester, and you'll select a campaign.

Week 3 (Jan. 27 and 29) – Approaching a thorny issue: systems thinking and theory of change

Thorny social issues don't exist in a vacuum. This week, we'll explore how to examine issues in the context of a larger system. Plus, we'll define "theory of change" and discuss how we apply a theory of change to public interest communications campaigns.

Week 4 (Feb. 3 and 5) – The six spheres of influence: Part 1

This week, we'll introduce a core public interest communications framework: the six spheres of influence. The spheres help public interest communicators develop a strategic approach to broad problems.

Week 5 (Feb. 10 and 12) – The six spheres of influence: Part 2

We'll continue exploring the spheres of influence and look at how they are at play in your campaigns.

Week 6 (Feb. 17 and 19) – Introducing the four-questions framework

This week, we'll introduce another framework: the four-question, back-of-the-envelope guide to strategic communications. What makes an effective goal in a public interest communications campaign? How do public interest communicators identify who to mobilize to achieve that goal? We'll answer these questions and more.

Week 7 (Feb. 24 and 26) – The science of message framing

This week, we'll delve into the third question in the framework, which leads us to explore the science of message framing and the importance of values-based messaging in reaching people with a range of worldviews and identities.

Week 8 (March 3 and 5) – Making people care about big issues

The larger a problem is and the more people it affects, the more likely people are to tune out, research shows. This week, we'll explore the research that explains this phenomenon and what communicators can do to make people care about big problems.

Week 9 (March 10 and 12) – The science behind emotions

This week, we'll talk about the science behind emotions as well as how to balance powerful rhetoric with facts to motivate people to act. We'll learn about social math and what makes an effective call to action.

SPRING BREAK! (March 17-21)

Week 10 (March 24 and 26) – Using news media to reach your actors

Although local news is atrophying, the news media landscape has undergone other changes that offer new opportunities for public interest communicators to reach people. This week, we'll explore those opportunities and learn what news reporters consider newsworthy and how to attract the attention of reporters.

Week 11 (March 31 and April 2) – Case study work

This week, we'll work on our final projects and prepare next week's presentations about social media platforms.

Week 12 (April 7 and 9) – Using digital media to reach your actors

The digital media landscape is vast. Which platforms should you use? How do you ensure your actors see your messages? This week, we'll dive into social media and how to use digital media to move people to action. And you will be the guides! You'll work in teams to present information to the class about one social media platform.

Week 13 (April 14 and 16) – Visuals

We'll examine the power of visuals in social change efforts and identify elements of an effective visual.

Week 14 (April 21 and 23) – Final project work

This week, those who wish to present their case studies for an extra assignment will do so. The final projects are due April 23.
